

PET AMBASSADOR OWNER/SPONSOR AGREEMENT

This agreement is made between the Mustang Chamber of Commerce, Mustang, Oklahoma (hereinafter referred to as “Chamber”), and [name of pet owner] _____, residing at the address _____ (hereinafter referred to as “Pet Owner”), on _____, 20____.

I. Definitions.

Pet Ambassador. The pet elected by the people of Mustang and outlying areas to reign as the Mustang Pet Ambassador during the time period August 1, 2024 to July 31, 2025.

II. Pet Owner Requirements.

1. Accompany the Pet Ambassador at each event or appoint an alternate (age 18 or over) to accompany the Pet Ambassador. Pet Ambassador must never be left unattended. Pet Owner shall have direct control of Pet Ambassador at all times. Pet Owner agrees Pet Ambassador is not a Vicious or Dangerous Animal or Noisy Animal as stated in the City of Mustang, Oklahoma Code of Ordinances.
2. Attend with the elected Pet Ambassador to at least six (6) Chamber events, including but not limited to Mustang Western Days, during the time period mentioned. Pet Owner and the Chamber will determine the events the Pet Ambassador will attend.
3. Pet owner will provide food, water, any medication, and any other accommodations for Pet Ambassador. Pet Owner will handle all sanitary and waste needs.
4. Pet owner will provide proper restraints to protect the public from danger.
5. Notify Chamber of any changes to Pet Owner’s contact information during the term of this agreement.

6. Pet Ambassador must be current on all vaccinations. Pet Owner will provide Chamber with a copy of all Pet Ambassador veterinary records, registration certificates and licenses, if applicable.
7. Pet Owner agrees to authorize Chamber to edit, copy, change, and make use of all photographs, videos, and audio recordings of Pet Owner and/or Pet Ambassador to be used for promotional purposes. Pet Owner authorizes Chamber to utilize photographs for, but not limited to, publication on the internet, magazines, journals, books, newsletters, provided it is done for lawful purposes. The aforementioned material is sole property of the Chamber. Pet Owner hereby releases all rights to any, but not limited to, claims, rights, demands, and/or causes of action by Owner or Owner's representatives, heirs, or anyone else. Pet Owner hereby waives any right to royalty or any other compensation with respect to the use of photos, videos and audio recordings.
8. Pet Owner agrees the Pet Owner will not receive any compensation from the Chamber and any expenses related to the position of Pet Ambassador, other than the expenses specified in Section III, which will be borne by Pet Owner and/or its sponsor.
9. Pet owner will not use the Pet Ambassador title to support a political or religious position.
10. Pet owner agrees to comply with all pet owner requirements in Chapter 14-Animals, Code of Ordinances, City of Mustang, Oklahoma. Any citations issued during the reigning of Pet Ambassador shall be the sole responsibility of Pet Owner.
11. Pet Owner agrees the Pet Ambassador does not have rabies or any other contagious disease.
12. Pet Owner is solely responsible for injuries to the people of the public as a result of an appearance by Pet Ambassador during the term of this agreement.

III. Chamber Requirements.

1. Chamber will provide royalty clothing/items to wear at the events.
2. Chamber will contact media outlets as necessary to promote Pet Ambassador.
3. Chamber will handle reservations for the Pet Ambassador for events during the term of this agreement.
4. Chamber is independent from the Pet Ambassador sponsors and in no way has entered into any Pet Ambassador agreements with the sponsors.
5. Chamber is not responsible for any injuries to Pet Owner and/or Pet Ambassador resulting from making appearances as Pet Ambassador.

IV. Termination.

Chamber reserves the right to terminate this agreement at any time for any reason. Pet Owner must provide thirty (30) days notice of termination of this agreement to the Chamber in writing to the address or email address listed herein.

V. Indemnification.

Pet Owner shall indemnify, defend and hold harmless Chamber against any liability, damage, loss or expense (including reasonable attorney fees and expenses of litigation) incurred by or imposed upon Chamber in connection with the Mustang Pet Ambassador program.

This agreement is effective immediately and will continue for as long as the Pet Owner's pet serves as Pet Ambassador. The Pet Ambassador sponsor (if applicable) is not a party to this agreement.
