### What is my business type?

There are three categories to choose from when deciding on your business type:

*Business* is a typical company providing products or services, such as a grocery store or financial institution.

*Nonprofit* is a 501-C3 or 501-C6 organization, such as a church or club.

*Individual* is a retiree or person wishing to get involved in the Mustang Chamber and not associated with a particular business.

### Why should I invest in the Mustang Chamber of Commerce?

By investing in us, you are giving us the opportunity to help you *grow your business*.

### What is the size of my business?

The size of your business is determined by the number of full-time employees you have on staff.

If you have several part-time employees, add up the number of full-time schedules (Total part-time hours divided by 40) you have.

### How long does it take to process my Membership application?

Membership approval can take up to 30 days for processing. Once payment is received with the application, it will be reviewed at the next Board of Directors meeting for approval. You will then receive a letter welcoming you to the Mustang Chamber of Commerce and receive the full benefits of membership, including the ability to create your own membership package.
